

Before Your Departure:

Purchase a Test Kit Register for Your Test

1. Purchasing a Test Kit

The Abbott test kit can be ordered several different ways. Order your kit anytime before travel, however no fewer than 5 business days before your departure.

1. From the <u>United Airlines website</u>

You will be directed to either Optum or eMed's website to complete your purchase, depending on the number of kits you order.

2. From the <u>American Airlines website</u>

From this page, you will be directed to eMed's website to purchase a test kit.

- Directly from the <u>eMed website</u> (6-pack kits only)
- 4. Directly from the Optum website (2- or 3-pack kits only)

What Are the Technical Requirements?

The device you bring with you to take the test must:

- Be internet enabled with an updated internet browser (Safari, Chrome, Edge, Samsung Internet)
- Have a microphone, speakers, and a front-facing webcam or camera


Each person taking a test must have an individual email account as well as the ability to log in to that account.

One email address per person.

A single email account shared with multiple persons is not compatible with this experience.


In this example, a 2-pack test kit was ordered from the Optum website.

Click on "Get Started" on the Purchase Page.



A questionnaire will launch. Fill out the questions as they pertain to you.

At the end, click on "Proceed to checkout" and enter in your information to complete your purchase. After your purchase, you will receive a receipt and an email confirmation for your order.




You will receive an email when your test kit is shipped, and another when it is delivered (around 3 business days).



When you receive your test kits in the mail **<u>do not open the</u> <u>individual kits.</u>**







Regardless of the device you are using to take your test (smartphone, laptop, iPad, etc.) you will:

Open your device's internet browser, navigate to <u>www.emed.com</u>, and select "Start Test".



Select "Login with Navica". Using your account information, login and follow the prompts on screen.



You will answer several short questions. Fill out the prompts as they apply to you. Before continuing:

- Ensure that your testing location has a broad, flat surface.
- If you are using a smartphone, ensure that there is something on the desk/surface that you can prop your smartphone up against during the test.

You will need both hands free to take the test and have to be in constant view of the camera.

When you are ready to begin testing, click "Join Guided Session" at the bottom of the page.

Follow the prompts on the screen to be connected to a testing proctor.



Once you are connected, the proctor will guide you through the test, step by step. C

eMed.

Here are the steps you will follow:

- 1. Show your ID.
- 2. Open the test kit when instructed.
- 3. Hold up your test card the QR code will be scanned by camera.
- 4. Squeeze 6 droplets of liquid on test card as directed.
- 5. Swab each nostril five times.
- 6. As directed, insert swab into card and rotate.
- 7. Close test card with adhesive strip
- 8. Wait for results (next slide)



If you are disconnected during your session, click the box in the lower right corner to reconnect. If you need to speak with customer service for any reason, ensure that you dial "011" before the phone number to make an international call. The proctor will set a timer on the screen for 15 minutes.

You will wait 15 minutes for your test result to process.

Do not disconnect from the session or touch the test card during this time.

When the timer reaches 0:00, you will be prompted to continue.





Your test is complete.


You will receive your results by email within 60 minutes.

Enter in your birthday in MMDDYYYY format to unlock the document.



Ensure that you download a copy of your results to your device, as well as take a screenshot of your results and save them to your photos.

When you check in for your flight home, you will need to show a copy of these results.
